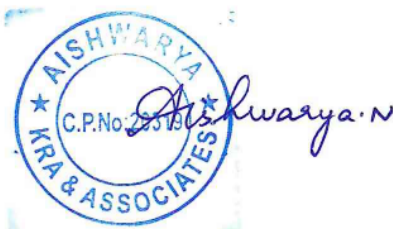

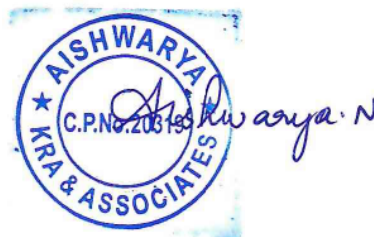

Golden Star Assets Consultants Pvt Ltd (Golden Star) (the Transferor Company) into Trinity (the Transferee Company), as sanctioned by the Honble National Company Law Tribunal (NCLT) via its order dated July 24, 2025, under Sections 230 to 232 of the Companies Act, 2013. The scheme has become effective on 19th August 2025.
